Imaging Equipment Fee Schedule

EPEAT Registry Access (EPEAT Participation Fee)

Effective for New or Renewing EPEAT Participating Manufacturers July 1, 2017 – June 30, 2018

Payment of the appropriate fee below enables an EPEAT Participating Manufacturer to place onto the EPEAT Registry products that are declared to an approved EPEAT Conformity Assurance Body (CAB) to be in conformance with the requirements of the EPEAT Program and the specific criteria of IEEE 1680.2, which covers printers, copiers, scanners, facsimile machines, multifunction devices, mailing machines and digital duplicators (Imaging Equipment). The fee is paid annually.

Engaging one or more CABs is required in order for products to appear on the EPEAT registry. See the list of available CABs [here](#). A Participating Manufacturer may use more than one CAB.

EPEAT fees are for one year, beginning on the date of enrollment. The fees below apply both to new and renewing manufacturers of Imaging Equipment for the time period between July 1, 2017 and June 30, 2018.

The EPEAT Participation Fee is based on the Manufacturer’s 2016 global sales of their branded products, stated in U.S. dollars. Global sales include all product types covered by IEEE 1680.2 (printers, copiers, scanners, facsimile machines, multifunction devices, mailing machines and digital duplicators) whether or not those products meet EPEAT environmental criteria or are registered on EPEAT.net.

Term and Invoicing

New Participating Manufacturers may contact the Green Electronics Council to request an invoice for the appropriate revenue tier. Registry privileges will be granted once the License Agreement is complete, an approved CAB has been engaged, and the Fee is paid. Renewing manufacturers will receive an invoice 90 days before their renewal date.
